Warm Greetings from Villa Silvina Hotel and Restaurant!

Baguio City is still on MGCQ status and border protocols are still in place, however traveling to the City is possible provided you submit and follow procedures required before you are allowed entry to the City of Baguio.

1. Prior to travel, all tourists are required to accomplish and submit via online the City's prescribed Health Declaration Form. Link below:
  - a. Go to **visita.baguio.gov.ph**
  - b. Click "**Sign up**" and register for an account.
  - c. Click "**Schedule a Visit**" and choose a desired schedule.
  - d. Accomplish needed information and documents.
2. Prior to entry, the LGU of the City will send you an email on the status of your request to enter the City.

Note: The number of persons allowed to enter the City is being regulated and screened by the City including your expected time arrival which should be **on or before 12:00 noon** of your scheduled date of arrival because the Central Triage Area closes at 3:00 in the afternoon

3. On your arrival, you will be asked to present the following documents at the City's Checkpoint located on all borders of the City.
  - a. Medical Certificate with latest Covid19 Test from the Health Office/Center of place of origin. (Testing can also be done at the Baguio City Triage for an Average of Php 1,300.00)
  - b. QR Coded Tourist Pass, which you shall be using in all tourism establishments in the City.
4. After travel documents are presented and assessed by the City's Checkpoint, you will be escorted to the **Tourism Triage** (located at Baguio Convention Center) for registration, profiling, body temperature taking and health/risk assessment interview.
5. After assessment you will be cleared if you have met all safety and health requirements. Depending on the results of your assessment if you fail to meet the requirements, you may not be allowed to proceed to your place of destination in the City and you will either be sent home or escorted by the City's Health Office representatives to Baguio Teachers Camp for a fourteen (14) day quarantine, or to the Baguio General Hospital for treatment.
6. Villa Silvina Hotel and Restaurant requires all guests entering its premises to comply with the following:
  - a. Present or show to our Guard on duty a copy of your **QR Coded Travel Pass, Medical Certificate with Covid19 Test.**
  - c. All guests are required to subject themselves to a body temperature check, footwear disinfection and hand sanitizing at the Main Entrance and Common Areas of the Hotel.
  - d. Wear face mask at all times.
  - e. Practice Physical Distancing at all times.
7. Villa Silvina Hotel and Restaurant reserves the right not to accommodate anyone (even if there is a confirmed reservation) if he/she fails to comply with all the requirements of the Local Government of Baguio City and by the Villa Silvina Management.
